

IMU CHARIOFARE RUN 2024

Terms and Conditions

Please read all the terms and conditions ("Terms") carefully. Individual who registers to participate in Chariofare Run 2024 ("the Event") (in the case of a participant below the age of 18 years, the participant's parent, guardian, or legal representative) ("Participant") declares and acknowledges to have read, understood, and agreed to the Terms below and undertakes to comply with and be bound by the same.

A. THE EVENT

1. The Event is owned by IMU University (Formerly known as International Medical University) ("Organiser").
2. The Event will be held on 7 September 2024 ("Date"). The Organiser reserves the right to postpone or cancel the Event at any time.
3. The Event is a family-friendly event, and it is open to all. Each participant attends the Event on his or her own free will.
4. Prizes Winners:
 - 4.1. Winners must be personally present to collect their prizes after the race upon the announcement of results. All uncollected prizes will be forfeited.
 - 4.2. The Organiser reserves the right to request for the winners' original identity card or passport for age verification.

B. THE REGISTRATION

1. By signing up for and providing any information, personal or otherwise, to gain access and to participate in the Event or any activities relating to the Event, the participant is deemed to have given express permission to the Organiser and Event partners and sponsors (if any) to use such personal information for marketing, statistical and planning purposes.
2. The participant shall be responsible for the accuracy and correctness of the information provided in the registration form. The Organiser shall not be responsible in any way whatsoever to check and verify the information and/or consent so given.
3. By signing up for and providing any information, personal or otherwise, the participant agrees to provide his/her name and personal details to the insurance partner of the event for the purchase of Group Personal Accident Insurance (compulsory by the Sports Commissioner).
4. The Organiser reserves the right to contact the participant from time to time by any means. Any notice sent to the email address registered with the Organiser shall be deemed as received by the participant.

5. If a participant provides any information that is untrue, inaccurate, outdated, or incomplete, the Organiser may suspend or terminate the participant's registration and refuse any and all current or future use of any components of the Event. There will be no fee refund upon such suspension or termination of the participant's registration.
6. The Organiser will not entertain or be in any way responsible for any disputes arising from incomplete or inaccurate Registration Data in the Event registration form completed by the participant.
7. Once the participant's registration has been duly processed, there will be no refund for any participant who does not eventually take part in the Event for whatever reason.
8. All merchandises provided are subject to change without notice.

C. THE PARTICIPATION

1. The participant hereby acknowledges that he/she takes part in the Event at his/her own risks and he/she shall assume full liability and responsibility for any mishap, injury, damage, accident, ill health, death and hereby releases and holds the Organiser, their sponsors and their appointed officials harmless from any liability.
2. There will be no refund on registration fees if the Event is cancelled for reason of force majeure i.e., due to occurrence of incidents that are beyond the control of the Organiser (including but not limited to haze, storm, rain, inclement weather, wind, act of God, terrorism, or other conditions) and which in the Organiser's opinion, renders it impossible or unsafe to hold the Event.
3. The Organiser reserves the right to change the date, venue or to cancel the Event at any time without prior notice to the participants, in which case the Organiser will make every effort to inform the participants prior to the Date. If the Event must be cancelled, there shall be NO refund of fees and the Organiser shall not be liable for any other loss or inconvenience caused.
4. The Organiser reserves the right to amend the Route as the Organiser deems fit and any amendments/variations will be made known by way of notice posted on the Website and such other form as the Organiser may decide and the participant is deemed to have due notice of the same.
5. The Organiser reserves the right to amend the Rules and Regulations of the Event which will be reflected on the Event's website and social media, and it is the responsibility of all the participants to keep abreast with any changes.
6. The Organiser shall not be liable for any other loss or inconvenience caused due to such amendments/variations.
7. The Organiser reserves the right to refuse entry or to remove any participant whom in the Organiser's sole opinion, is guilty of jostling, obstructing or involves in an act of aggression against another.
8. Number bib given to the participants during the Entry Pack Collection are compulsory to be always worn during the Event. Entry will be prohibited otherwise.
9. By participating, the participant is assumed to be fit and able to participate and/or complete the Event and where applicable.
10. The participant shall run on the designated route and observe the signage and/or safety regulations.

11. While every reasonable precaution will be taken by the Organiser to ensure the participants safety, participants attending the event are solely at their own risk and the Organiser will not be responsible or held liable for any injury or death however arising from training for, during or after participation in the Event. Participants are strongly encouraged to go for a medical examination and/or to consult their medical practitioner prior to registration and before the actual Event day.
12. The Organiser cannot be held responsible for lost, damaged or stolen property during the session.
13. Participants must ensure that they have read and understood the Personal Data Protection Notice on the collection, retention, use, disclosure and management of the Participant's personal data. By reading and agreeing to it, Participants agree to authorise and allow the Organiser and/or any of its subsidiary companies to collect, retain, use and disclose the Participant's personal data for the purposes mentioned in the Personal Data Protection Notice.
14. The Organiser reserves the right to use the names, photographs and video recordings taken before, during and after the Event for purposes of advertising and/or publicity without any prior notice to the participant and the participant shall not claim ownership or compensation for the materials.
15. The participant hereby gives his/her consent to and authorizes the Organiser to disclose his/her particulars to third party service providers and/or sponsors appointed and/or collaborated in relation to the Event.
16. By registering and participating, the participant hereby expressly agrees to be bound by these Terms and Conditions and the decision of the Organiser.

D. GENERAL

1. The Organiser's decision on all matters relating to the Event shall be final and binding and no further correspondence or attempt to dispute such decision will be entertained.
2. The Organiser reserves the rights to change, amend, delete or add to the terms and conditions of the Event without prior notice and the participant shall be bound by such changes.
